It is considered a "private sports activity" the one that uses the municipal sports facilities by companies or individuals, as well as by sports entities for unusual activities.

The registration of the request does not imply that the activity is authorized.

25% of the total fee to be settled will be paid as a reservation at the time of receiving the confirmation, at the latest, three weeks before the start of the activity

The supplement for lighting in any sport facility is 10%

The period between the beginning of Holy Week and July 31 is considered high season. The rest of the year as low season.

Bonus: in case of reserving and paying in advance for the use of a Ciutat Esportiva Blanes track with a rental of more than 30 hours, a bonus of 15% will be applied to the price of the rate.

If accommodation is reserved in the "Associació d'Hosteleria de Blanes" (hotel or apartment) a 35% discount will be applied to the price.

The sports department will have a single interlocutor in the organization of the activity.

The space and the requested sport equipment is subject to availability. Priority will be given to authorized activities.

The company/physical person/organizing entity will be responsible for the cleaning and subsequent adaptation of the activity space, as well as the management of waste at the end of the activity.

It is the responsibility of the company to coordinate volunteers and collaborators in the organization of the activity.

The sports department will apply the ordinance that regulates the use of the sports facilities by third parties

*When the sports modality of the club does not coincide with the use of the requested facility.

*For the organization of non-ordinary activities (festivals, tournaments, evenings, etc.) and activities with income from registration.
